ORDER:-

The Government is of the view to establish exclusive Corporation to Reddy Community and allocate sufficient funds to the said corporation thereby it can be supportive of the economically weaker people of the said community.

2. The Reddy is a community among other castes is known as OC community and most of them are agricultural families. Among the community, though a few individuals possess large land holdings having assured irrigation facilities, majority of them are small and marginal farmers having no assured irrigation facilities and due to vagaries of monsoon and persistent drought conditions the yield of the crop is affected and by taking into account the raising agricultural inputs and in the absence of remunerate price, the income of the families are affected and resulting in poverty.

3. In recent times, more emphasis was also laid on education, for which agricultural lands are sold/ mortgaged to carry on education, since education is thought to be the alternate tool to eradicate poverty. The economic disparity among the same community is resulting in economic unrest and to neutralize the same, institutional finance is required.

4. In order to achieve the above, the Government have decided for formation and establishment of "**Andhra Pradesh Reddy Welfare and Development Corporation**" under A.P. Societies Registration Act, 2001, for **Reddy** Community.

5. Accordingly, Government after careful examination hereby form and establish "**Andhra Pradesh Reddy Welfare and Development Corporation**" under A.P. Societies Registration Act, 2001. The orders on the structure of the Executive Committee (Governing Body) to the aforesaid Corporation and its staffing pattern will be issued separately in due course.

6. The Director, B.C. Welfare, A.P., Vijayawada shall take further necessary action in the matter accordingly.
